SECTION 2: HAZARD IDENTIFICATION

EMERGENCY OVERVIEW

WARNING: This product is a clear colorless thin liquid with a citrus fragrance. Direct contact with eyes can cause irritation. SECTION 4: FIRST AID MEASURES
